Item#1: Executive Session to discuss a Personnel Issue pursuant to MRSA Title 1 Section 405 (6)(A).

5:00 p.m. Motion made by P. McDonough, seconded by D. Martin, to move to executive session to discuss a Personnel Issue pursuant to MRSA Title 1 Section 405 (6)(A). (5 yes) So voted.

Item#2: TIF Workshop – Immediately following the executive Session or at 6:00 p.m., whichever is later.

Alain Ouellette, from Northern Maine Development Commission (NMDC), reviewed, explained, and discussed Tax Increment Financing (TIF).

- To better understand a TIF it is necessary to understand local taxes
- A TIF is one tool to promote job growth and assist the expansion of businesses
- It can help shelter new captured value by excluding it from the total municipal value that is reported to the state.
- Within a TIF District the values are frozen.
- Allowable project costs are capital costs including construction, improvement and site work, demolition, repair and/or remodeling, purchase of machinery and equipment, professional services, town administrative expenses, relocation costs, organizational costs, and certain infrastructure.
- Mr. Ouellette reviewed the TIF amendment process.
- The Bouchard TIF was discussed and what the captured assessed value may be used for.
- Funding mechanisms include municipal bonds and credit enhancement agreements (CEA).
- TIFs may be designated for up to 30 years.
- Following a revaluation the original assessed value (OAV) can be amended.
- CEAs should be looked at on a case by case basis.
- Mr. Ouellette recommends that the City invite members of the Department of Economic & Community Development (DECD) to Caribou for a work session.
- A map of the Downtown TIF was reviewed.

- LD 563 An Act to Clarify Tax Increment Financing has been introduced this Legislative session.
- Currently CEAs are not allowed in the Downtown TIF.

Council Consensus: Council wants greater flexibility in the Downtown TIF and to pursue an amendment to the TIF to obtain this flexibility.

Item#3: If Necessary: Executive Session to discuss an Economic Development project pursuant to MRSA Title 1 Chapter 13 Section 405 (6)(C).

Council Agenda Item #15: Maine Military Authority Lease

Maine Military Authority (MMA) no longer uses the City's facility at 60 Access Highway and on March 15, 2013 officially returned the keys. The City of Caribou has not received any lease payments since December 1, 2010, when MMA's lease automatically renewed. The lease payment amount due the City is \$40,034.25. According to the lease agreement, MMA is responsible for maintaining the plumbing, heating system, roof and outside walls, and windows. A Property Condition Assessment was updated in August 2012 which shows that the building needs approximately \$175,700 in repairs.

Council suggested contacting the state legislative delegation and the Department of Veteran Affairs.

Motion made by P. McDonough, seconded by K. Murchison, to authorize the City Manager to write a letter informing Maine Military Authority of the City's intent to utilize the City Attorney and the legal process to recover the funds necessary to complete the repairs and the back rent. (5 yes, 1 abstention, A. Kouhoupt) So voted.

Item#1: Discussion on General Ledger and Reserve Account

- Previously the City Councilors had received a copy of the March General Ledger Summary Report and a summary of the Library Trust Accounts. Finance Director Raymond briefly reviewed the report noting the City's assets and liabilities and provided very basic accounting lesson explaining debits and credits. Council and Department Managers questions were answered.
- Cash flow is tightening and the City has been preapproved for a Tax Anticipation Note (TAN).
- The City's Undesignated Fund Balance is \$1,099,226.50.
- Supt. Mazzuchelli explained each of the twenty-seven Parks & Recreation reserve accounts.

Item #2: Other Discussion

- Discussion concerning the 2012 budget process under the adopted 2011 Charter and how at times it has been painful.
- Mayor Aiken wants procedures developed for the budget process. He stated that the City needs to consider revenues while working on the expense budget.
- A general discussion as to the advantages of changing the City's fiscal year to match the State fiscal year. Consensus: This warrants further discussion and study.
- Prior to the development of the budget, the City Manager needs to receive direction from the Council.
- A general discussion concerning volunteerism, how to develop new energy for the Caribou Cares about Kids festival, how to attract people to visit Caribou for events such as the upcoming hog rally, and the development of a downtown committee.

Bids for the Library Roof project were opened on Thursday. Here is a listing of the bids:

Kevin W. Smith and Sons \$ 91,000.00 Powers Roofing and Sheet Metal \$ 92,754.00 Roof Systems of Maine \$148,830.00

A letter from the engineer regarding the bidders will be available for Council tonight.

Engineering fees will be \$7,000. Assuming Council accepts the lowest bid the total project cost would be \$98,000.

We have \$105,261 set aside in the reserve account already, and \$29,000 set aside for the project this year in the Capital Expense account. Total funds are \$134,261.

Council will need to award the bid and authorize the City Manager to sign any and all necessary documents to execute the project.

As Council can see he has not been billed since 2005, as he no longer owns the property. This tax is still remaining. The principal and interest are not on the General Ledger therefore abatement is not needed in order to clear this.

FAIR HOUSING RESOLUTION

STATE OF MAINE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

LET IT BE KNOWN TO ALL PERSONS of the City of Caribou that discrimination in the sale, rental, leasing, financing of housing or land to be used for construction of housing, or in the provision of brokerage services because of race, color, religion, sex, handicap, familial status or national origin is prohibited by Title VIII of the 1968 Civil Rights Act (Federal Fair Housing Law). It is the policy of the City of Caribou to implement programs to ensure equal opportunity in housing for all persons regardless of race, color, religion, sex, handicap, familial status or national origin. Therefore, the Town does hereby pass the following Resolution:

BE IT RESOLVED that within available resources the City will assist all persons who feel they have been discriminated against because of race, color, religion, sex, handicap, familial status or national origin to seek equity under federal and state laws by filing a complaint with the Maine Human Rights Commission or the U.S. Department of Housing and Urban Development, Boston Regional Office Compliance Division.

BE IT FURTHER RESOLVED that the City shall publicize this Resolution and through this publicity shall cause owners of real estate, developers and builders to become aware of their respective responsibilities and rights under the Federal Fair Housing Law and any applicable state and local laws or ordinances.

SAID PROGRAM will at a minimum include but not be limited to: (1) the printing and publicizing of this policy and other applicable fair housing information through local media and community contacts; (2) distribution of posters, flyers and any other means which will bring to the attention of those affected, the knowledge of their respective responsibilities and rights concerning equal opportunity in housing.
