A Resolution of the Caribou City Council Authorizing the Filing of an Order of Discontinuance for Park Street (Between Bennett Drive and Glenn Street)

WHEREAS the City of Caribou, RSU 39, and Assisted Living of Caribou, LLC have entered into an agreement to transfer real estate, which was accompanied by a Scheduling Agreement for Real Estate Transfers (Agreement) dated May 30, 2017; and

WHEREAS, the City of Caribou has certain obligations under the Agreement which pertain to the discontinuance of Park Street,

NOW THEREFORE, let it be resolved that

ORDER OF DISCONTINUANCE

Pertaining to

Park Street (Between Bennett Drive and Glenn Street)

The City of Caribou hereby issues this order of discontinuance, in accordance with State of Maine statutes, Title 23, Part 3, Chapter 304, §3026-A, for that portion of Park Street between Bennett Drive and Glenn Street, as provided below. <u>This order does not make the discontinuance effective.</u> The City Council must first conduct a properly noticed public hearing, vote to approve the discontinuance, and record a Certificate of Discontinuance in the registry of deeds before the discontinuance will take effect.



Damages to Adjacent Property Owners: None. The discontinuance is a pre-negotiated term between the City of Caribou and RSU 39 which enables better design and constructability of the new Caribou Elementary School.

Public Easements will NOT be retained. However, should any public utilities be located within the discontinued area, the above referenced State of Maine statute indicates, "An easement for public utility facilities necessary to provide or maintain service remains in a discontinued town way regardless of whether a public easement is retained." Any relocation or disturbance of existing utilities in the discontinued area would be subject to communication with and approval by the affected utility companies.

Description of Park Street to be Discontinued:

Beginning at the southwest corner of that property designated on the Caribou Tax Maps as lot 84, map 34, said point being coincident to the eastern edge of the public right-of-way associated with Glenn Street, thence easterly along the property line to the southeast corner of the same property, which is coincident to the western edge of the right-of-way for Bennett Drive, thence southerly to the northeast corner of that property designated on the Caribou Tax Maps as lot 100, map 34, said point also being coincident to the western edge of the right-of-way for Bennett Drive, thence west along property lines to the northwest corner of that property designated on the Caribou Tax Maps as lot 85, map 34, said point being coincident to the eastern edge of the public right-of-way associated with Glenn Street, thence northerly to the point of beginning.
