a. Discussion and Possible Action Regarding Official Proclamation Declaring September 2017 Child Cancer Awareness Month

Motion made by P. McDonough, seconded by D. Martin, to adopt a Proclamation declaring September 2017 Child Cancer Awareness Month. (6 yes) So voted.

Councilor Theriault read the Official Proclamation (Exhibit A).

The mother of Zachary Gagnon thanked the Council for their proclaiming September 2017 Child Cancer Awareness Month. On October 22, 2016, 13-year Zachary lost his battle with cancer. In the past 2-1/2 years, ten Aroostook County children have been diagnosed with children cancer. Each year, throughout the United States, one in 285 children will be diagnosed with cancer.

Motion made by P. McDonough, seconded J. Smith, to approve the abatement of property taxes for multiple properties totaling \$2,507.25. (6 yes) So voted.

c. Discussion and Possible Action Regarding EMS Capital Vehicles and Equipment Needs

Over a month ago, an ambulance was totaled in an accident. Since then the City has been going back and forth with the insurance company. It appears that the City only had liability coverage on this piece of equipment and will receive a total payout of \$24,000. The insurance company did come through for the expensive equipment that was on board. Once an ambulance is ordered, it takes approximately 6 months for delivery.

Council discussion centered around the number of ambulances needed by the City for long distance transfers and available for local calls. The Chief stated that he has looked at the data from January 1<sup>st</sup> to August 31<sup>st</sup> and that there would have been a \$208,000 loss to the City, if the City hadn't had a 5<sup>th</sup> ambulance. The loss for 2016 would have been \$223,000 and \$217,000 for 2015.

The Council questioned why the City only had liability on the ambulance. The Chief stated that it was that way to save money, but now the ambulances have full coverage. The full coverage started about two weeks ago. If the City had had full coverage at the time of the accident, the City would have received \$160,000 rather than the \$24,000 payout.

When asked by Council, the Chief commented that van style ambulances don't work very well on the interstate during the snowy winter months.

#### Costs for a New Ambulance:

New Ambulance \$201,000
Credit for old Engine 1 - 10,000
Credit for wrecked ambulance - 20,000
Capital Reserve - 24,000

Currently the City is using a loaner ambulance, at no cost to the City, from the ambulance dealer. The dealer hopes to sell the City a new ambulance, if there isn't a sale then they will want their ambulance back.

Motion made by D. Martin, seconded by N. Cote, to purchase a new ambulance. (4 yes, D. Martin, N. Cote, J. Smith, T. Guerrette, 3 no, P. McDonough, J. Theriault, G. Aiken) So voted.

Motion made by J. Smith, seconded by D. Martin, to trade-in former Engine One for \$10,000 towards the purchase of a new ambulance. (5 yes, 1 no, P. McDonough) So voted.

The City will be able to continue using the loaner ambulance, at no charge, until the new ambulance is delivered. Insurance coverage has been reviewed line by line, item by item for the department's entire fleet and this is being done for the other departments also.

#### Council Agenda Item #9: Reports of Officers, Staff, Boards, and Committees

a. City Manager – Historical Expenses and 8 Month Budget Report City Manager Marker has reviewed the budget and is projecting that the City will come in under budget for 2017. He noted that any department projected with a cost overrun; such as, economic development should be offset by additional revenue through the hard work of the Gary Marquis and Christina Kane-Gibson.

The City Manager will be continuing to review the budget and will provide any update to Council before the Charter established deadline of September 15<sup>th</sup>.

#### Council Agenda Item #10: Reports and Discussion by Mayor and Council Members

- Nomination papers are available for three Council seats, two RSU #39 seats, and one Jefferson Cary Board seat. The term of office for all seat is three years. Nomination papers are due by 5:00 p.m. September 22<sup>nd</sup>.

Supt. Marquis received one bid on the Grist Mill Park Project from Haney's Building Specialties out of Caribou. The bid was for \$34,175, which includes deck, earthwork, prepping and asphalting the ramp. The bid is within the estimate range projected by Marquis. The money to complete this project are in the department's reserves.




The Planning Board has determined that this property is residential in nature and should be allowed to continue as a residence, with a new dwelling and garage being a positive addition for the neighborhood.







RE: Jamie and Jessica Bell Request for 2016 Tax Abatement

**DATE:** October 2, 2017



Mr. Jamie Bell is requesting an abatement of \$1,863.33 or 48.6% of the 2016 tax bill (see attached letter and calculation) for his property located at 318 Grimes Mill Road. Mr. Bell's taxes for that period were \$3,833.46.

Mr. Bell petitioned for abatement earlier this year and the board of assessors determined that no adjustment to value was warranted based on the property improvements on the day of commitment. Procedurally, this was the most correct action for the board to take since their primary concern is valuation and the valuation process. Abatement on the other hand falls under the purview of the city council.

If the City Council entertains abatement of the taxes, any decision must be based on those circumstances outlined in state statute Title 36 §841. Those instances where abatement is allowed include the following:

- To correct any illegality, error or irregularity in the assessment,
- When a person is unable to contribute to the public charges due to hardship or poverty,
- If after 2 years, a person is unable to pay due to death, absence, poverty, insolvency, bankruptcy or other inability, and
- When application is made by an unremarried widow or widower or minor child of a veteran.

The last three circumstances are not applicable in this case as the Bells have paid the assessed amounts each year, are current residents of the city, and do not fall into the final category. Relative to the first possible circumstance for abatement, the city staff can find no illegality or error in the process of determining the valuation of the property but recognize the irregular event of the home being burned down during the tax period. If the Council so chooses, they may lean on the premise that Mr. Bell's irregular circumstance warrants abatement of a portion of his taxes for fiscal year 2016.

We lost our home of the past ten years to a fire on May 11, 2016. The house was a total loss. Although our garage was not damaged in the fire, it was burglarized on June 9 (Police Report #1745-16). In addition to losing our home, we have also lost the current use of our garage due to the increased risk of additional burglaries while we are not currently living on the property.

Our current tax bill reflects taxes on our home for the full 2016 tax year. We are asking to have a modification to our bill that reflects the loss of our house. The following breakdown illustrates: (1) the house taxes for the time the house was on the property, (2) the taxes on the land and garage for the full year, and (3) the total tax that we are requesting.

Thank you for your consideration in this matter. The loss of our family's home and sense of security has been a tremendous hardship over the past several months. We appreciate your willingness to work with us during this difficult time.

First we would need to know how much to sell so we would need to talk to Dave to find out how much room he needs. Just quickly measuring, it looks like – at most – it would be .14 acre which is not a buildable lot. If it was sold, it should be with the understanding that he add it to his lot by combining the deeds.

Caribou's in-town lots are priced based using "fractional acreage" on the typical lot size per neighborhood (for this neighborhood it is .25 acre), find the square root, then multiple by the base lot unit value. For this (and most) neighborhood that would result in a base lot value of \$10,000 on a typical lot. Using this methodology, that value would be \$7,500 but since it is not a buildable lot, we would need to apply a factor, which means looking for a similar type property (i.e. a .14 acre lot could be buildable if it was created before May 1980 and could conform to set backs so I would need to find one – like this one – created after that date) for comparison and see how it was valued.

His current lot is .21 acre. If he added .14 acre to it, it would raise his valuation by about \$1,000 (the access acreage over the base lot is priced as rear land.)

So this is what I would tell the Council. Who knows what they would set for a price!

Good morning Police Chief Michael Gahagan, Interim City Manager:

Last week you asked me to look into Larry Newell's request to purchase some city-owned land adjacent to his property at 93 York Street. I am attaching the information about that adjacent parcel which was Map 29 Lot 12. Page One is a section of the 2016 version of City Tax Map 29. Page Two is from the 1984 aerial maps in the assessor's office. Pages Three thru six is the condemnation order from 1986 when the City compensated the property owner after taking the property by right of eminent domain as part of a Community Development project. I am also attaching a .pdf file of the area from the State of Maine ArcGIS Server with the Newell lot highlighted.

This should answer the question as to how the City of Caribou acquired title to the property. A legal opinion would be required to find out the process for conveying a portion of a parcel that was acquired by eminent domain.

Penny,

There are two issues to consider:

- (1) If the "lawn portion" was formally designated as part of the road that was laid out by the Council, it would still be considered a road even if it was not developed. The only way to remove the road designation is through the discontinuance process or the abandonment process. The city could discontinue the portion of the road that is the "lawn portion" by going through the discontinuance process. If the city also extinguished the public easement in that portion of the road, ownership of the property would cede to the abutters on either side of the road. The statutory abandonment process in 23 MRSA § 3028 might apply if there was no maintenance by the city for 30 consecutive years, but a public easement would remain if that process was used. If this is a part of a road, the discontinuance process would be the best method of dealing with it. We have detailed information on the process in chapter 3 of our *Roads Manual* (https://www.memun.org/Member-Center/Manual-Collection/Roads)
- (2) Also, you indicated that the land was acquired as part of a community development plan. There is a law that authorizes eminent domain for community development purposes (30-A MRSA § 5203) which does limit municipal rights to dispose of property acquired by eminent domain under authority of that law. The previous version of that law, 30 MRSA § 4853, was in place in 1985 when the plan you mention was approved. If Caribou's plan was adopted pursuant to this law, the limitations on sale would apply. In summary, the law says (and said) that a municipality may not dispose of undeveloped property within 10 years of its taking without first offering it to the prior owner(s) or their heirs. There are some exceptions that don't appear applicable and timing requirements that I won't reprint as I know we are well beyond 10 years from 1985. However, the last sentence of that section states that "disposition of this property other than to the prior owner(s) or their heirs requires use of the property in accordance with the community development program." It is not clear whether this requirement is limited by the 10 year restriction or applies beyond that time. I don't know if the abutters are the people who owned the land originally or not so maybe this would not be an issue.

I'm happy to delve further into both the issues discussed above depending on what you find as to whether the law mentioned above was the authority for the plan and whether the parcel at issue was actually part of the road or not.





The owners were paid \$26,500 on July 15, 1986. The roadway was extended per the development plan, the remaining lawn portion was not needed or developed. Is there any special process for selling land acquired by the City through this type of action? There is a provision in the City charter that the City Council "may convey or lease any lands owned by the City of Caribou except for tax acquired property" (which has its own process) and that conveyence "shall be by ordinance". Just wanted to check if there was anything special about City lands acquired by the eminent domain. Thank you in advance for the help. --Penny





# C. \$6000 STEPHEN & TABITHA KING GRANT AWARDED TO LIBRARY FOR NEW HEATING/AC UNIT IN CHILDREN'S ROOM

<u>Problem:</u> The children's room, added in 1985, also included three wall heaters. These heaters blow warm air into the room to keep it comfortable during the winter. In the last 5-6 years, there has been no heat coming from these units. The lines have been bled numerous times by Dead River but the heating pump always failed. Although it is not uncommon for wall heaters to function at 80% when it is extremely cold outside, these units either did not function properly or did not function at all.

There is also an air conditioner in the children's room. I am unsure when this was installed, but looking at the size of the chiller unit outside, it may be 5-7 years ago. The AC unit has a bottom cap missing, exposing pipes. The negative for this AC unit is in its inefficiency (costly to run).

With such a cold room during the winter season, children and families do not use this space to read or play and we need to change that.

Solution: Consulted with Dead River, March 2017. We were informed that three units were too old to be repaired. The air conditioner, although it worked, was not energy efficient. We wanted one good, efficient unit that could provide heat during the winter and cool air during the summer. A unit was recommended and a cost outlined for removal of old units, capping off pipes, and clean up. The new heating unit will run at 80% when temperatures outside dip down to -13 degrees below, a far cry from no heat at all.

Installation would include a new heat pump unit, the removal of existing units, reclaiming existing refrigerant, evacuating system to rid it of unwanted particles and moisture and testing.

<u>Funding</u>: The STK Grant was sent out on June 30, 2017 explaining our situation and want we needed the funds for. We are very happy to have received the funds necessary to proceed with this project. The new unit will be installed November 16 by Dead River.

Unit Model: Mitsubishi FH18 hyper heat pump providing 18,000 BTU's of cooling, and 20,300
BTU's of heating. Part of Mitsubishi's hyper-heating product line is a packaged single zone heat
pump mini split system designed to bring high-efficiency zoned comfort in frigid climates.

## CIE 413/411 Capstone Project Summary: Collins Pond Dam, Caribou, Maine

# **Project Location**

The project site is located at the outlet of Collins Pond in Caribou, ME. Collins pond is maintained by the remnants of an approximately 76 foot wide dam at the outlet of the pond, where the dam crest has been eroded significantly and the elevation reduced. Water flows from the pond into Caribou Stream and then the Aroostook River. Collins Pond was formerly a mill pond, where the eroded dam is the last remaining feature of a grist mill.



Figure 1: Location of Collins Pond Dam in Caribou, Maine.

## **Project Overview**

Collins Pond is known in the Maine birding community to be one of the best viewing sites for Canada Geese migration. However, the water level has dropped significantly since the crest of the dam and flashboards have deteriorated to an elevation at the present water level. The reduction in the water level over the last years has led to significant vegetation growth along the bank from more dry conditions and decreasing acreage and volume of water in the pond. To remedy this and preserve the Pond, the Caribou Parks and Recreation Department, with Maine DEP support, would like to reestablish the dam crest to the previous water level and restore the pond to at or near its original shoreline.

#### **Project Scope**

The Collins Pond Dam project should address the following:

- Storage capacity of the pond: Evaluate the existing and historic dam and pond water surface elevations based on existing water level, historical records, and the height of the dam crest and flashboards that remain along a section of the original dam. Identify environmental and shoreline impacts that will result from increases in the water level to historic elevations.
- <u>Hydrology</u>: Estimate surface flows from the contributing watershed based on appropriate precipitation occurrence intervals (e.g. amount of water).

- <u>Design Iteration</u>: This design section can consider either complete removal of the dam and new construction or refurbishing the dam.
  - Structural/Geotechnical Design: Evaluate the dam and determine if a simple increase in crest elevation can be performed or a full redesign the dam is required. The design solution must includes structural design of a full dam height, its foundation, and appropriate outlet structures. The client requests either a concrete gravity or stone masonry design (no wooden crib works or steel).
  - O <u>Hydraulic Design</u>: Estimate the rate of water flow over the proposed dam structures and through designed outlet structures (e.g., weirs, spillways, and others as appropriate) in response to a range of the rate watershed surface flow inputs. Use this information to design outlet structures and create stabilization criteria for the downstream dam face, toe, and downstream channel stabilization, as appropriate (e.g., supercritical flow, hydraulic jumps, dam face erosion).
  - Historical Preservation: Determine if historical preservation is required for the existing
    dam structure or the site and make recommendations and designs that accommodate this,
    as appropriate.
- <u>Construction recommendations</u>: Provide recommendations for construction that include
  consideration for how to manage any requirements for water discharge into Caribou Stream
  during construction (e.g., maintaining minimum base flows or cutting off flow), conceptual
  construction sequencing, removal or reuse of materials from the compromised crest, and Collins
  pond refill time.

# **Project Evaluation Criteria**

The project designs will be evaluated, and documented in the design report, based on the following criteria: design life; construction costs; demolition/disposal costs of current dam remnants (if necessary); operations and maintenance procedures and costs; environmental implications; and historical preservation implications. It is expected that other criteria discovered during design as necessary for project evaluation will additionally be used for assessment and documented in the design report.

The project design is required to evaluate several options and provide an opportunity for either internal (project team) or external (client) decision-making. Internal decision-making means the team has evaluated several design options to a certain point, evaluated these options in a systematic and documented manner, and then selected one option to move forward with in completion of the project. External decision-making means the teams have evaluated several options through a similar design process and evaluated them based on a series of documented criteria and options are presented to the client. *Possible decision-making opportunities for this project relate to different dam and outlet structure types and geometries, recommended normal pond levels (e.g., crest height variation)*.

#### **Team Selection Criteria**

A successful project will provide feasible solutions based on the client requirements and requests, evaluate the project options based on client and team-driven criteria, and understand permitting requirements and constraints applicable to the project and design the project around these. A successful project will provide design solutions for reestablishment of the dam and pond elevation that addresses appropriate environmental concerns and permitting around the pond and historical significance.

The *primary project disciplines* are hydrology/water resources, structural engineering, and site/civil. Project *secondary disciplines* relates to geotechnical and environmental engineering. A team of 5 or 6 student engineers will be selected to lead this project that clearly and successfully demonstrates expertise related to these primary and secondary civil engineering disciplines, where experience from internships related to design, construction, and permitting will be given top priority and coursework specialization given secondary priority during team selection.
