The Caribou Utilities District is a quasi-municipal entity created by charter from the Maine Legislature in 1945 to provide water and wastewater services to the City of Caribou. The District is directed by a five-member Board of Trustees appointed by the Caribou City Council. The District is self-financed through rates paid by its customers and maintains its own budget separate from the City. The District produces all drinking water from two gravel aquifer wells on the River Road. These sources provide high quality water for our customers. A new water treatment plant was completed in 2006 and is capable of producing up to 2 million gallons of water per day. The District also maintains 32 miles of water mains, two booster stations, four standpipes and 150 fire hydrants. A wastewater treatment plant was completed in 1984 and is capable of treating up to 1.7 million gallons of wastewater per day. The District operates and maintains three aerated lagoons (39 million gallons total), 35 miles of sewer mains, two pump stations, eleven lift stations and 700 manholes.
