Councilors,

Pursuant to Section 13-850 of the Caribou Code;

The Caribou Planning Board held a public hearing on March 11, 2021 to consider an amendment to the Caribou Zoning Map:

Rezone a portion of Tax Map 10- Lots 39-B, 40 and 41, (450, 467 and 473 Sweden Street) from Residential 1 (R-1) to Residential 3 (R-3)

The R-1 District is intended primarily for older residential neighborhoods within convenient reach of business facilities. This district is expected to contain higher-density single-family dwellings.

The R-3 District encompasses most of the area outside the urban center and is intended for the kinds of uses more traditional in rural areas, such as farming, farm residence, and other uses not inconsistent with a generally open, non-intensive pattern of land use. The minimum lot size requirement is high, in order to prevent overdevelopment, where public sewer is not feasible and the full range of urban services cannot be provided economically.

The Caribou Planning Board received a request from Jessica and Dwayne Gagnon at 467 Sweden Street and Melissa and Alhassan Badahman at 471 Sweden Street, and in response to the Public Notice, from Judy and Bryan Corrow at 450 Sweden Street, to rezone their respective properties from R-1 to R-3, citing the desire for a more rural lifestyle and the ability to have and to keep poultry and livestock. The Caribou Planning Board agreed that the impacted area currently in the R-1 district historically has been rural in nature, consisting of former family farms and agricultural lands. Thus, the Caribou Planning Board voted in favor of sending a recommendation to the Caribou City Council that the requested change to the Caribou Zoning Map be adopted.

The Caribou Planning Board hereby requests that the City Council consider this request, and if adopted, initiate the process to amend the Caribou Zoning Map accordingly.

AN ORDINANCE AMENDING CHAPTER 13, SECTION 13-202, ZONING MAP

Short Title: An Ordinance amending the Caribou Zoning Map.

WHEREAS, the City of Caribou is a Local Unit of Government under the State of Maine and is granted home rule authority under Maine Revised Statutes, Title 30-A, §3001; and

WHEREAS, the City of Caribou has adopted Chapter 13, Land Use Ordinances as part of its ordinances and regulations, which outline land use laws and zoning regulations; and

WHEREAS, a request has been made to amend the official zoning map in order to facilitate the more beneficial use of land and properties for economic advancement within the community; and

WHEREAS, the City Planning Board conducted a public hearing on March 11, 2021 to receive comment on the proposal, which hearing was preceded by the notification of affected land owners and the general public in accordance with city notification procedures, and

WHEREAS, the City Planning Board has forwarded a positive recommendation to the City Council for the proposed rezoning.

NOW THEREFORE, the City Council of the City of Caribou, County of Aroostook, State of Maine, pursuant to the requirements of the City of Caribou Charter, Section 2.11, does ordain the following:

Section I. Zoning Map Amendment




Section II. Severability




The DEP does not regulate demolition concrete and masonry brick and block materials that are considered inert (all rebar must be removed) and these materials can be used as beneficial fill.

That being said, we should consider the characteristics of the material and how it would be applied to the site. In larger cities where demolition occurs to make room for immediate redevelopment there would be an engineering spec for any material to be buried.

- Collapsing the foundation into the hole and burying it may work in situations where redevelopment is not being considered, otherwise the cost of removal may be realized by the future developer.
- 2. Large chunks of concrete (greater than 1') when buried are not compactable and create voids resulting in uneven settlement, erosion and create favorable conditions for burrowing rodents. Larger sized concrete can be better used to reinforce sloped areas and armoring culvert outlets.
- 3. Small sized concrete debris (6" to 8" +-) though still not a compactable material, would create lesser voids but still does not offer structural integrity enough to trench and form up foundation walls. Material of this size might also be used as beneficial fill to shape and contour the property and allow for drainage.
- 4. In order to reuse demo debris concrete material in building construction, it would need to be passed through a crusher and be applied as 1" +- gravel that is compactable and could be used for subsurface base for slabs, foundations and roads.
- 5. The more we handle this product in order to bury on site, the more cost we drive into the demo project and must be carefully weighed as compared to disposal trucking cost.
- 6. Due to construction limitations from burying on site, we must also weigh the value and potential of redevelopment on a parcel as opposed to saving on disposal trucking cost. If currently redevelopable properties that are close to services and infrastructure become undevelopable due to buried debris, future growth will need to sprawl onto undeveloped properties.

AN ORDINANCE AMENDING CHAPTER 4, SECTION 4-103.2, BUILDING DEMOLITIONS, PERTAINING TO ONSITE BURYING OF DEMOLITION DEBRIS

Short Title: An Ordinance amending demolition debris disposal regulations.

WHEREAS, the City of Caribou is a Local Unit of Government under the State of Maine and is granted home rule authority under Maine Revised Statutes, Title 30-A, §3001; and

WHEREAS, the City of Caribou has adopted Chapter 4, Building and Housing as part of its ordinances and regulations, which outline laws and regulations affecting construction and demolition of structures within the city; and

WHEREAS, the City Council requested that standards pertaining to disposal of demolition debris within the urban compact area be reconsidered.

NOW THEREFORE, the City Council of the City of Caribou, County of Aroostook, State of Maine, pursuant to the requirements of the City of Caribou Charter, Section 2.11, does ordain the following:

Section I. Code Amendment

Section 4-103.2 of Chapter 4 Building and Housing is amended as follows: (stricken text is deleted, underlined text is added)

Sec. 4-103.2 Building Demolition

- a. Any building or structure to be demolished within the City of Caribou, (urban or suburban) requires a Demolition Permit issued by the Code Enforcement Office. Any property owner wishing to obtain a demolition permit must provide the CEO with proof of ownership or a copy of the deed, a completed Demolition Permit Application and schedule of demolition activity. All demolition clean-up and at least one foot of gravel cover with loam and mulch must be completed within one year from the date the permit is issued.
 - Any contractor applying for a Demolition Permit on behalf of the property owner must also provide a copy of a signed contract by the owner. Any person wishing to demolish a building must provide written proof that all utility providers have removed service from the building to be razed.
- b. The Caribou Fire Department must be notified at least 5 business days in advance of the commencement of demolition. At the discretion of the Caribou Fire Chief or their designee, the Fire Department may choose to burn the building as a training exercise provided the property owner initially request such action for consideration.
- c. Prior to the commencement of demolition, on the day the building is to be razed, the site must be inspected by Caribou's Building Official.
- d. No demolition debris may be buried on site within the Urban Compact Zone. Demolition debris may be buried on site if located outside of the Urban Compact Zone with the following provisions:
 - 1.) No debris may be buried within 100 feet of any property line.

- 2.) No debris may be buried within 100 feet of an existing water well.
- 3.) Biodegradable and Inert demolition debris may be buried on site.
- 4.) Inert materials such as brick, concrete or stone, if conditions will allow, may be buried on site, hauled to an off-site gravel pit or delivered to a Licensed Disposal Facility.
- 5.) All <u>structural lumber</u>, <u>structural steel and all non-biodegradable debris such as asphalt shingles</u>, asbestos, carpeting, sheetrock, vinyl or metal siding, painted materials or similar materials must be delivered to the Tri Community Landfill or another Licensed Disposal Facility. If materials are to be delivered to a Licensed Disposal Facility, a copy of the contract with the Disposal Facility must accompany the Demolition Permit Application
- 6.) The burial site must be covered with sufficient loam and seeding to prevent erosion of the site unless established as impervious surface pursuant to the redevelopment of the site.
- e. A final inspection is required. The owner or contractor must notify the Code Enforcement Officer at the completion of site recovery.

Note: Maine State Law requires demolition notification to the Department of Environmental Protection for certain buildings and buildings with asbestos to be made by the owner. A record of any demolished building buried on site must be recorded at the Registry of Deeds for Aroostook County in Houlton.

Section II. Severability

If any part of this ordinance or the application thereof to any person or circumstances shall, for any reason, be adjudged by a court of competent jurisdiction to be unconstitutional or invalid, such judgment shall not affect, impair of invalidate the remainder of this ordinance or the application thereof to other persons and circumstances, but shall be confined to its operation to the section, subdivision, sentence or part of the section and the persons and circumstances directly involved in the controversy in which such judgment shall have been rendered. It is hereby declared to be the intent of the City Council that this section would have been adopted if such invalid section, provisions, subdivision, sentence or part of a section or application had not been included.
