



It is proposed that the City Manager, Penny Thompson, be authorized to approve City Treasurer's Warrants for the 2023 calendar year. The city charter already authorizes the manager to be the purchasing agent for the City (See §3.04(11)). However, state code, Title 30-A §5603 requires an annual vote of the municipal officers to authorize warrant approvals pertaining to wages and benefits or disbursement of state fees. If authorization is not granted to the Manager or other designated municipal officer, then the full Council will need to approve all wage and benefit warrants. This would mean the council would need to approve each payroll.

The Tax Club allows for persons to participate in a program whereby their 2023 Tax Commitment will be divided into 12 equal monthly payments and the participant will pay this estimated tax accordingly. Once the 2023 Commitment has been made, the final payment on their actual 2023 commitment, the difference between their 2022 commitment versus their 2023 commitment, will be adjusted for their December payment. Participants will also not incur interest on their account for the months of October, November and December as part of the program. Many persons find this type of payment program beneficial, especially the ability to pay their last three payments absent interest on their account.

DATE: January 3, 2023



At the next meeting, the 2023 City Council priorities can be finalized. This is included in this meeting packet for discussion, if desired by the 2023 Mayor.

The spreadsheet of 2022 priorities are included for reference. Updates on some 2022 priorities:

Public Safety

Police Station Design & Referendum – Referendum vote passed in June 2022; Chief Gahagan and City Manager Thompson attended a training on constructing police facilities in September 2022; CDS request for \$2.5 million was approved. The Caribou Organization Promoting Public Safety (COPPS) has been formed and officially recognized by the state and IRS as a public non-profit organization. Additionally grant funds can now be sought.

Opioid and Drug Enforcement – The City Council has heard from individuals and families who have been affected by the opioid crisis.

Fire Station Operational Upgrades – using capital budget funds and ARPA funds (including ARPA grant funds from the County of Aroostook), work is ongoing at the fire station. Additionally, a grant was submitted and awarded to replace the generator with a properly sized unit. However, global supply chain issues have delayed installation.

Community Outreach – The Police and Fire department Facebook pages regularly provide timely information to citizens.

Marijuana Retail Establishment Requests – This is ongoing. Several members of the Caribou City Council have attended meetings provided by the Maine Office of Cannabis Policy.

Ambulance Billing Contract – With Caribou's long-time ambulance biller retiring, Caribou is now contracted with a third-party provider, Comstar.

Emergency Preparedness / Resiliency – Currently working out the last details on a resiliency grant from the Governor's Office of Policy Innovation and Future for a digital communication tool at the Fire Department, IAmResponding, and one for citizens, TextMyGov. (Van Buren also has TextMyGov.)

Other priorities in this category still need work.

Administration

Employee Retention – The City Council worked to provide wage increases for all employees starting January 1, 2023. The Fire Union saw their increases start earlier in the year. Fire and Police moved to a retirement plan in line with those offered at other local agencies. Caribou lost some great employees in 2022 and we wish them well in their new careers and are grateful for the contributions made during their time working here.

Grant Administrator / Outreach Coordinator – Caribou is fortunate to be able to have a part-time grant administrator with many years of experience. Successful grants in 2022: County ARPA, CDS for Police Station, Riverfront Renaissance planning grant, Maine Office of Tourism grant and others. A huge project was the submission of the FY2023 Brownfields Grant. Fingers crossed. We have contracted with local firms to handle much of the social media outreach lately due to turnover of staff in the City Manager's office.

Other priorities in this category still need work.

Community Development

Blight removal – This was very successful in 2022. Through the tax acquired property process, the City acquired several nuisance properties that went out to bid and were torn down. More work is needed.

Business Directory & Newsletter – Caribou sent out a business newsletter this summer and hopes to continue this practice.

Branding and Marketing – The Visit Caribou campaign is going well! Grant funds have allowed us to build a page on the City's website to build excitement for Caribou businesses.

2024 Comprehensive Plan update – Successful kick-off in October.

Other priorities in this category still need work.

Infrastructure

Broadband – The Caribou City Council and staff spent a lot of time on this in 2022. ARPA funds were used to fund the project study for an all-fiber network. The CUD charter was changed to allow for a fiber division.

Municipal Buildings Deferred Maintenance – The Municipal Building committee but a lot of effort into crafting a capital expense request to maintain our City assets. Work is ongoing.

Solar Power Purchase Agreement – done. The City should begin seeing a savings in the coming months when the project is online.

Other priorities in this category still need work.

Leisure Services

Recreational Trail Enhancements – Staff worked to connect South Main businesses to the ATV trail. Staff has petitioned the DOT to allow a trail to businesses on the Fort Fairfield Road. Work is ongoing in many areas.

Thursdays on Sweden – A very successful season. The City had a booth on Sweden Street to connect with residents and get their feedback on important issues. Sponsors are lined up for next year to make it bigger and better.

Library Programs – The Caribou Public Library continues to receive praise for its outstanding line-up of programs and services.

Age-Friendly – The Age-Friendly Caribou group has been active this year with a greeting card outreach, Tech Talks, and Senior Santa. Related to this, Caribou reestablish the Boston Post Cane for the oldest citizen and recognition for Caribou Centenarians who are citizens 100 years old and older.

Rehabilitation of the Caribou Mill Pond and Dam – The City of Caribou will be receiving over \$4 million in a CDS request for work on the Caribou Mill Pond and Dam.

Other priorities in this category still need work.

Economic Development

Façade Improvement Grants – Caribou had two successful grant periods in 2022.

Riverfront Redevelopment – The CRRC has been working on zoning and fund raising.

Downtown Revitalization – The City is working with the Department of Transportation on a Village Partnership Initiative to leverage grant funds to revitalize our downtown and improve traffic patterns.

Affordable Child Care barriers – Work is ongoing. There was a listening session held at the Wellness Center this year.

Other priorities in this category still need work.

Note: The City Manager has been attending training courses and conferences to make connections with industry professionals and look for ways to position Caribou as an attractive place to do business. Efforts are paying off with many commercial property sales in recent months.
