Council Agenda Item #8: New Business & Adoption of Ordinances and Resolutions

Mayro Boma explained that according to the Caribou City Charter, the Council shall conduct Regular Meetings at least once in every month. Additional special meetings, work sessions or emergency meetings may also be convened in accordance with Maine Open and Public Meeting laws and the Caribou City Charter.

2025 Budget Adoption Schedule from the charter:

Budget public forum by February 15

Final budget to City Council by March 1

Public hearing & vote by the third Monday in March (March 17, 2025)

b. Discussion and Possible Action Regarding Collection of Property Tax Prior to 2025 Commitment

Mayor boma explained that it is proposed that the Council authorize the Tax Collector to accept payments of property tax prior to the 2025 commitment date. Maine state statute16 provides that cities may authorize prepayment and pay interest on the payments, "at a rate not exceeding 8% per year; municipalities are not obligated to authorize the payment of interest on taxes prepaid..." The municipality is obligated to return any excess money paid over the final commitment amount.

Motion made by Councilor Lovewell, seconded by Councilor Watson to authorize the Tax Collector to accept early payments of 2025 property taxes with a zero percent (0%) interest rate applied to any prepayment amounts.

Councilor Bagley would like to give back and does not support 0% on the prepayments if we charge 8% for late taxes.

c. Discussion and Possible Action Regarding Manager Authorization to Approve Treasurer Warrants

Mayor Boma explained that it is proposed that the City Manager, Penny Thompson, be authorized to approve the City Treasurer's Warrants for the 2025 calendar year. The city charter already authorizes the manager to be the purchasing agent for the City . However, Maine state statute requires an annual vote of the municipal officers to authorize warrant approvals pertaining to wages and benefits or disbursement of state fees. If authorization is not granted to the

Manager or other designated municipal officer, then the full Council will need to approve all wage and benefit warrants. This would mean the council would need to approve each payroll.

Motion made by Deputy Mayor Smith, Seconded by Councilor Watson to authorize the City Manager to review and approve all Treasurer Warrants for 2025.

d. Discussion and Possible Action Regarding Authorization to Provide a Tax Club for 2025

Mayor Boma explained that the Tax club allows people to participate in a program whereby their 2025 Tax Commitment will be divided into 12 equal monthly payments and the participant will pay this estimated tax accordingly. Once the 2025 Commitment has been made, the final payment on their actual 2025 commitment, the difference between their 2024 commitment versus their 2025 commitment, will be adjusted for their December payment. Participants will also not incur interest on their account for the months of October, November, and December as part of the program. Many taxpayers find this type of payment program beneficial, especially the ability to pay their last three payments absent interest on their account.

Motion made by Councilor Watson, seconded by Councilor Lovewell to authorize a Tax Club for 2025 as previously established. Providing for 12 equal payments of an accounts tax liability with no applied interest in October, November, and December for club participants.
