Council Agenda Item #10: New Business, Ordinances and Resolutions

a. Authorize City Manager Penny Thompson to sign loan paperwork associated with DECD BRLF

Manager Thompson explained that the Maine Department of Economic & Community Development (DECD) solicited applications through its for cleanup loans and grants at Brownfields properties throughout Maine. Along with its technical partner, the Maine Department of Environmental Protection's (DEP) Brownfields Program, the DECD BRLF Program will fund the cleanup of several Brownfields projects, preparing the sites for reuse. Representatives from EPA and DEP visited the Brownfields sites in Caribou in August and have encouraged the City to apply for this funding. The "Birdseye Site" has been acquired by the City of Caribou through the automatic lien foreclosure process and has been identified by the City Council as an ideal location for the new Police Station and future Business Center. We are in the process of gathering information, but it is Area of Concern 5 (remediation of PCB soils) at Birdseye that we would want to clean up with these funds. The estimate in 2017 was \$33,000.

With the City Council's approval at the August 2024 meeting, the City of Caribou prepared an application. The new estimate for the cleanup was \$48,000. An application was submitted. In October, the City learned that the application was approved. At the October 2024 meeting, the City Council approved the signing of the award letter. The next step is to approve and sign the loan documents. This is a 50% grant and a 50% low interest loan.

There are funds remaining in G 1-373-20 (from USDA after sale of 60 Access Highway) that could be used to help pay off this loan.

Motion made by Councilor Watson, seconded by Councilor Theriault to approve the note and loan documents for the DECD BRLF program and authorize City Manager Penny Thompson to execute the documents on the City's behalf.
