Manager Thompson explained that last February, the Caribou Development Committee held a "Housing Symposium" to gain a greater understanding of what the current challenges with housing, including workforce and middle housing, are in the community. It was open to the community and produced a lot of general feedback. This was followed by a roundtable with those involved in real estate, contracting, and development.

One key piece was that Caribou needs to have a housing inventory within the City of Caribou and develop a detailed housing action plan.

In March 2024, the City of Caribou applied for a Housing Opportunity Program municipal grant to fund a housing study.

In October 2024, the City of Caribou was notified by DECD that the City had a high scoring application. On February 20, 2025, the attached contract was received. This has been sent to Attorney Rick Solman for review.
