Good morning, Ellen –

Thank you for putting this out to the bidders so quickly. It is wonderful to see such a prompt response from Blane Casey. Do you think that we will receive similar responses from the other two firms?

This seems to mirror what Jan said in the meeting which is: pick someone to engage in a conversation with and work that to its conclusion. And if we can't get anywhere, move to the next one.

Members of the committee and I feel that time is of the essence here and we should try to figure out if this is a divide that can be crossed, given the difference between available funds and the base bids. The more time that lapses, public support for the project may wane if the message is, "we can't afford it". We need to be conveying a message of "we can get where we need to be".

First, a couple of questions: we understand that this is beyond the original scope of the agreement and would like to know what you will charge the City of Caribou to work on the value engineering of the project? If we receive a similar sentiment from the other two contractors (i.e. pick one firm and work with them), how quick can we meet and get the process started. The committee will need to give a report at the meeting on June 30 and it would be helpful to report that we are working on a solution.

Thank you so much for the bids today. I and the City appreciate the effort involved in producing them. However, we are stuck – the numbers are higher than the funds the City has available for this project. The other issue is, although Ganneston was the low bidder on base price, Blane Casey is the low bidder when the deduct alternates are factored in. And the lowest 3 bids which includes Bowman are separated by less than ½ of 1% - Really a tight bid!!!

The City would like to know whether any one of you are interested in participating a value engineering this project as we attempt to reach the money available for this project ?

I am reaching out to all 3, and keeping this as transparent as possible, because the numbers are just so tight. If you feel this is inappropriate, I will listen to that discussion as well, but the City has to do what it can to get to a place where the building can be built!
