 I'm attaching the BABA FAQs just for your reference, but in short: The BAP does not apply to FY2022 and FY2023 CPF Grants since they were legally obligated prior to February 22, 2024.
 This is an FY23 grant so does not apply to your project.



The BAP does not apply to FY2022 and FY2023 CPF grants, which were legally obligated upon Congressional enactment prior to February 22, 2024. Consistent with HUD's Phased Implementation waiver, if the FY2024 appropriations bill is enacted prior to February 22, 2024, the BAP will not apply to FY2024 CPF grants.

#### **Davis-Bacon**

Davis-Bacon and Related Acts compliance is NOT a condition or requirement for CPF funds. As I mentioned, it may be required if the project is also supported b other funds requiring adherence.
