These are the tough questions. I need some time to evaluate a lot of this. My general thought is that we designed a very resilient, rugged structure for a 75+ year lifetime which would resist any foreseeable situations. What is proposed, and apparently necessary to fit in the \$9 million budget, is a fully functional new Police Station, maybe not up to CALIFAA standards, and probably guarantee able for 25-30 years. I am not happy with the cuts, but current economics and pricing make this seem inevitable.

We have not had anywhere near enough time or information for fully vetted evaluation of their proposal, but most elements are the logical conclusion of the process.

Some is the issues that I immediately question is dropping the OH door at the sallyport to 12' height. If you can get your ambulance in that door, then their proposal to lower the plate height of the entire building, which offers a significant savings, is what makes the steel studs possible. We would need to run calcs to confirm the sizes, but the concept can be feasible.

By eliminating the basement and removing some storage and office spaces, we can get the mechanical into the building, potentially, and save a lot on the foundation by lowering the floor level a couple feet.

By removing any masonry, except the glue and stick style stone or brick, we save a large amount on the foundation.

These are all things I know were undesirable for you, but this is where we are.
