WARRANT FOR ASSESSMENT OF REGIONAL SCHOOL UNIT TAX

To the Assessors of the **City of Caribou**, in the County of Aroostook:

Under and by virtue of the provisions of 20-A M.R.S.A. §§1451-1512, the School Board of Regional School Unit 39 ("RSU 39"), organized in pursuance thereof, hereby issues its warrant for the assessment of taxes on the **City of Caribou** for the year covering the period of **July 1, 2024 to June 30, 2025**.

Whereas, the citizens of RSU 39, at the regional school unit budget meeting held **May 22, 2024** voted that the sum of **(\$23,444,101.59)** should be approved as the total budget for RSU 39, for the period **July 1, 2024 to June 30, 2025** plus the sum of **(\$243,500.00)** for Adult Education, and at the budget validation referendum held on **June 11, 2024** voted to approve the budget adopted at the budget meeting;

Whereas, the School Board of RSU 39 has determined that the total budget of **(\$23,444,101.59)** minus all other anticipated revenues, **(\$20,615,596.25)** require the sum of **(\$2,828,505.34)** to be assessed against the member municipalities of said RSU 39, for the period **July 1, 2024 to June 30, 2025**; and

Whereas, the School Board of RSU 39, on the **1st day of July, 2024** ordered that warrants be issued forthwith and sent out for assessing the municipalities comprising said regional school unit their proportionate shares, said shares being in accordance with existing statutes and the method of sharing costs among the member municipalities of said regional school unit, and for paying the same to the treasurer of said RSU 39;

Now therefore, agreeable to the provisions of 20-A M.R.S.A. §1489, you are hereby required in the name of the State of Maine and Regional School Unit 39 to assess the sum of **(\$5,501,382.07)**, upon the taxable estates within the **City of Caribou** according to the provisions of law for the assessment of taxes; and in making said assessment, you are required to add the sum aforesaid to the amount of state, county, and municipal taxes to be by you assessed.

And you are alike required to pay or issue your warrants to the several constables or collectors of said municipality requiring them respectively to levy and collect the sum of **(\$5,501,382.07)**, and to pay to the municipal treasurer the aforesaid sum set against said municipality, to be paid by said municipal treasurer to the treasurer of Regional School Unit 39 in monthly installments on or before the 20<sup>th</sup> of each of the months, **July 2024 to June 2025:**
